

The scanning and deposit of documents received as part of the EU Delegation collection in Washington DC was completed at the end of 2019. Beginning in 2020, virtually all new content added to the AEI will consist of papers from the private research organizations referenced above. Nevertheless, we are always on the lookout for new, relevant papers from scholars worldwide to add to the AEI.

The European Union as a New Context and Challenge for the Triangle of Greece, Cyprus and Turkey

Abstract

This paper deals with Greek-Turkish relations and the Cyprus problem in the context of EU interests and concerns in the region. It argues that today, more than ever before, the EU can play a catalytic role in finding a long overdue settlement on Cyprus and improving Greek-Turkish relations. Following the development of a spirit of rapprochement across the Aegean in the late 1990s, the accession of Cyprus to the EU in 2004, and the commencement of accession negotiations between Turkey and the EU in October 2005, the political setting in the region is changing. It is also argued that a settlement on Cyprus in the context of European integration has the potential to produce only winners, benefiting all parties involved in the island or concerned over peace and security in the Eastern Mediterranean.

Abstract

On 1 July, after months of speculation, Turkey's Prime Minister, Recep Tayyip Erdoğan, announced he would run in the country's first direct presidential elections on 10 August. Erdoğan, who has dominated Turkish politics for over a decade, is viewed as the clear favourite. With current polls suggesting he could take as much as 52% of the vote, an outright victory in the first round is possible. His main rival, Ekmeleddin İhsanoğlu, is very much the underdog. Until recently, an international diplomat with no experience in politics, he is the joint candidate of Turkey's two main opposition parties, the Republican People's Party (CHP) and the Nationalist Movement Party (MHP). Selahattin Demirtaş, the Co-Chairman of the Kurdish Peoples Democratic Party (HDP) is also in the race, but is not expected to make it into double digits. The Kurdish vote however, could prove to be crucial if the ballot goes to a second round on 24 August. With Erdoğan wanting to increase Presidential powers, the stakes are high. With his belief in majoritarian rule, and increasingly authoritarian style of governance there has been an erosion of democracy and civil liberties. Many observers fear this trend may increase.

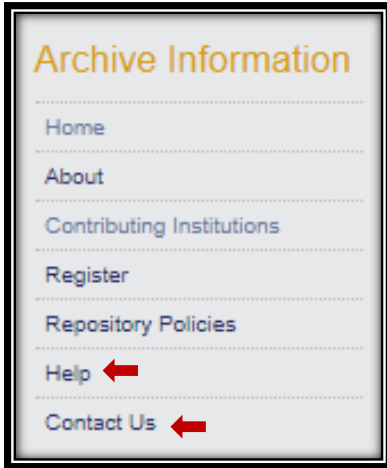
